1. All accessories must be manufactured or supplied by DMI for warranty to be valid.
2. Owner shall provide DMI with written notice within 30 days of the discovery of any DMI system failures.
3. This Warranty shall not be applicable if, in the sole judgment of DMI, any of the following shall occur:
  - a. The DMI system is damaged by wind in excess of one hundred ten (110) miles per hour or from flying debris, airborne objects, or natural disasters, including but not limited to tornadoes, earthquakes, lightning or fire.
  - b. The failure is due to separation of the wood nailer substrate (or other approved attachment member) from the building.
  - c. The DMI System is damaged by acts of negligence, accidents, misuse or abuse, including, but not limited to vandalism, civil disobedience or acts of war.
  - d. Metal work or other material not furnished by DMI is used in the DMI system.
  - e. Installing contractor fails to install the DMI system in the strict accordance with DMI's specifications and printed installation instructions.
4. This warranty supersedes and is in lieu of any and all other expressed warranties that are in conflict with the terms and conditions stated herein.

ALL IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PURPOSE WHICH EXCEED OR DIFFER FROM THE WARRANTIES HEREIN EXPRESSED ARE DISCLAIMED AND EXCLUDED FROM THIS WARRANTY.
